2.2 Indirect method

We may also collect data from;

- Third parties
- Data from social media platforms
- Automated services

2.2.1 Data from Third Parties

We may obtain information about you from various third parties such as data analytics providers, marketing or advertising service providers, fraud prevention service providers or publicly available sources.

2.2.2 Data from Social Media Platforms

2.2.3 Data through Automated Technologies

We may automatically receive or collect your data when you visit or interact with us either through a browser or mobile application.

- Device information,

- Files viewed on our site (e.g., HTML pages, graphics, etc.)
- Browsing actions and patterns,
- Software and hardware under usage
- Information about your visit to our website, including traffic data, location
 data, logs, and other communication data and the resources that you access
 and use on the Website.

You agree and admit that if you allow us to send you the information through newsletters, marketing material or other forms of information, we will treat such authorization as a permission to use or store such information until you actively withdraw such permission by clicking the link in the newsletter or by contacting via mail.

3. COOKIES

Torengue may use various methods, techniques and technologies for tracking the activity on our Website or App which include the use of cookies (or browser cookies). Cookies are small files stored on the hard drive of your device when you visit our Website or App via browser or mobile application. The information collected through cookies helps us to analyze and determine how frequently you are visiting Torengue and to enable us to enhance or personalize your experience with us. 5.1 Legal Purpose

5.4 Advertisement

These entities may send you promotional content about products and services that align with your preferences. You have the option to opt out of such communications or unsubscribe at any time.

6. PRIVACY RIGHTS UNDER THE GENERAL DATA PROTECTION REGULATION (GDPR)

While using the services provided by **Torengue**, you acknowledge and accept full responsibility for ensuring that all personal information submitted is accurate, complete, and up to date. Any inaccuracies in the information you provide may affect the services we offer and the execution of related transactions. You are solely responsible for maintaining and updating your personal data as needed.

In accordance with the **General Data Protection Regulation (EU) ("GDPR")**, users who are residents of the France, United Kingdom (UK) and the European Economic Area (EEA) are granted specific rights concerning their personal data, including but not limited to:

6.1 Right to Access (Article 15 GDPR):

You have the right to obtain confirmation as to whether or not your personal data is being processed, as well as access to such data.

6.2 Right to Rectification (Article 16 GDPR):

You may request the correction of inaccurate or incomplete personal information.

6.3 Right to Erasure ("Right to be Forgotten") (Article 17 GDPR):

You may request the deletion of your personal data under certain circumstances, such as when the data is no longer necessary for the purpose for which it was collected.

6.4 Right to Object (Article 21 GDPR):

You have the right to object to the processing of your personal data if it violates your fundamental rights and freedoms.

6.5 Right to Restriction of Processing (Article 18 GDPR):

Under certain conditions, you may request that we limit the processing of your personal data.

6.6 Right to Data Portability (Article 20 GDPR):

You have the right to receive your personal data in a structured, commonly used, and machine-readable format and to transmit it to another data controller where technically feasible.

6.7 Right to Withdraw Consent (Article 7(3) GDPR):

You may revoke any consent previously granted for data processing activities at any time, without affecting the lawfulness of processing conducted before such withdrawal.

All privacy related requests including GDPR shall be processed within seven 7 working days. We reserve the right to verify the identity of individuals submitting requests before processing them. The fulfillment of addition or deletion requests is subject to any applicable legal retention requirements. The exercise of privacy rights under GDPR shall not limit any other rights or remedies available under applicable privacy laws of France. 7. DATA RETENTION

You admit that we hold the rights to retain and securely store your personal data for period 3 years or as long as necessary to comply with our obligations such as:

You should be aware that no method of transmission over the Internet or method of electronic storage is completely secure. While security cannot be guaranteed, we strive to protect the security of your information and are constantly reviewing and enhancing our information security measures.
